
AFFIDAVIT OF SERVICE OF NOTICE

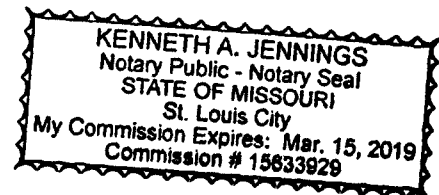

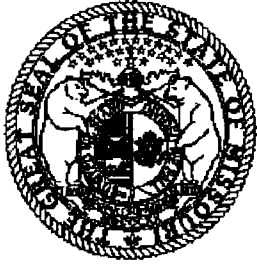

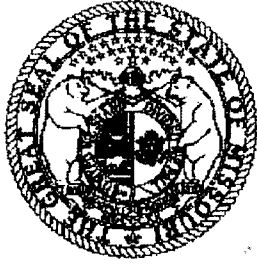
